

Fund summary

The Fair Oaks Dynamic Credit Fund (the "Fund") offers global access to senior secured corporate loans through investments in Collateralised Loan Obligations ("CLOs"). The Fund is actively managed with a strong emphasis on bottom-up fundamental credit analysis. The Fund primarily seeks exposure to investment-grade rated CLO securities on a long-only basis and with no leverage used at fund level.

Commentary

The Fund generated a net return of +4.68% in January.¹ The JP Morgan European High Yield Index returned +0.55%² and the European Leveraged Loan Index returned +1.63% in the month.³

The portfolio's gross yield to maturity is 7.0% and the gross yield to expected call is 8.0%. This compares to the yield to maturity of 6.8% for the JP Morgan European High Yield Index. 2

The European loan default rate increased from 1.62% to 1.86%, and the US loan default rate decreased from 1.53% to 1.47% in January. The forward-looking distress ratio decreased from 4.32% to 2.84% in Europe and decreased from 6.36% to 5.48% in the US. 4

While 2024 CLO new issuance is forecast to be in line with 2023 volume, CLO spreads have tightened significantly since the start of the year, helping to drive record activity in the primary market. CLO new issue volume totalled €1.4bn in Europe and \$10.7bn in the US. In Europe for the first time since June 2022, CLO AAA spreads of a managed deal (as opposed to a static or shortened reinvestment period) printed below 150 bps, a sign of a returning CLO equity arbitrage.⁵

The recent rally spurred by positive macroeconomic sentiment has resulted in a higher than usual proportion of the loan indices priced above par and a subsequent wave of loan repricings.⁶ This has a positive effect on the fundamental credit quality of loans, as interest margin is cut, and may cause CLO spreads to compress in tandem. Moreover, the probability of CLO repayments increases as equity NAV improves, liability discounts close and CLOs continue to amortise.


We have previously highlighted that since May 2023, European CLO BBB spreads have been unusually wide compared to high yield bonds spreads, presenting an opportunity for higher carry and for potential spread tightening. While CLO BBBs have outperformed high yield bonds recently, spreads remain relatively wide by historical standards. CLO BBB spreads are currently 20 bps inside high yield bond spreads vs a historical average of 68 bps.⁷ This, along with a higher credit rating and embedded structural protections against losses, should continue to support performance for the Fund in 2024.




